CAES COVID-19 Decision and Action Tree









COUGH







SYMPTOMS may appear 2-14 days after exposure to the virus and include new symptoms that are not associated with a chronic illness or condition that has been previously diagnosed by a medical provider.

Throughout the document, Resident refers to ANY individual that enters CAES facility.

CONTACT

CAES Resident lives with or has had close contact with someone who has symptoms or tested positive.

NOTIFICATIONS

- Notify CAES COO immediately.
- Notify your Associate Director. If you do not have an Associate Director, contact COO.

ACTIONS

- If on-site, leave the facility immediately. Self-isolate while exposed and for 14 days after last day of exposure.
 - » If the contact is tested and tests negative for COVID-19, employee can stop self-isolating and return to work.
- If resident develops symptoms, see Trigger #2.

TRIGGER SYMPTOMS

SHORTNESS OF BREATH

CAES Resident has symptoms.

NOTIFICATIONS

- Notify CAES COO immediately.
- Notify your Associate Director. If you do not have an Associate Director, contact COO.

ACTIONS

- If on-site, leave the facility immediately. Stay at home and seek an evaluation by a medical provider.
 - » If not tested for COVID-19, or if test is negative, self-isolate for at least 10 days after illness onset and at least 3 days after symptoms have improved.
 - » If resident tests positive for COVID-19, refer to Trigger #3.

TRIGGER POSITIVE TEST

CAES Resident tests positive for COVID-19.

NOTIFICATIONS

- Notify CAES COO immediately.
- Notify your Associate Director. If you do not have an Associate Director, contact COO.

ACTIONS

- If on-site, leave the facility immediately. Stay at home, self-isolate, and follow the advice of a medical provider. Do not enter the CAES facility until cleared to do so by the COO and the Associate Director.
- CAES COO and CSO will develop a list of residents who were in close contact in order to notify them of the need to self-isolate for 14 days.

TRIGGER TRAVEL

CAES Resident plans to travel to an international or domestic location with substantial community spread or states where case rates are higher than Idaho.

NOTIFICATIONS

Prior to travel, speak with your Associate Director, who coordinates with CAES COO, to discuss if a quarantine period will be necessary upon return.
