The following is data from the Maryland website on April 28, 2020:

- 20,113 confirmed cases statewide compared to 19,487 yesterday (increase of 626 cases or 3.2%).
- 4,003 confirmed cases in Montgomery County compared to 3,843 yesterday (increase of 160 cases or 4.2%).
- 929 confirmed deaths statewide, represents 4.6% of total cases. In addition, there are 87 "probable deaths" that have not been confirmed by testing.

- 201 confirmed deaths in Montgomery County; an increase of 11 from yesterday. Represents 5.0% of confirmed cases. In addition, there are 20 "probable deaths" that have not been confirmed by testing.
- 1,528 people are currently hospitalized; 977 are in acute care.
- 4,268 cumulative hospitalizations statewide; represents 21.2% of confirmed cases.
- 1,295 persons have been released from isolation statewide.
- 87,672 negative tests statewide.

COVID-19 Background (from Maryland.gov)

COVID-19 is a disease caused by a respiratory virus first identified in Wuhan, Hubei Province, China in December 2019. COVID-19 is a new virus that hasn't caused illness in humans before. Worldwide, COVID-19 has resulted in thousands of infections, causing illness and in some cases death. Cases have spread to countries throughout the world, with more cases reported daily.

COVID-19 is thought to be able to spread like the cold or flu through:

Coughing and sneezing, which creates respiratory droplets Close personal contact, such as touching or shaking hands Touching an object or surface with the virus on it

Symptoms of COVID-19 include:

Fever Coughing Shortness of breath In more severe cases, pneumonia (infection in the lungs)

The vast majority of people recover from this infection. Most people will have mild or moderate symptoms. Older people and those with pre-existing medical conditions have a greater risk for more serious illness.
