COUNCIL DECISION POINTS & COMMITTEE RECOMMENDATION

- The supplemental appropriation was introduced on March 10, 2020.
- No Committee review. Council staff recommends approval.

DESCRIPTION/ISSUE

MCPS received funding from the Maryland State Department of Education for the Concentration of Poverty School Grant program, established through Senate Bill 1030, the Blueprint for Maryland's Future. The program provides financial assistance for community supports and wraparound services to local education agencies and schools with high numbers or percentages of students from lowincome families.

MCPS is collaborating with DHHS to fulfill the requirements of the program by increasing somatic and mental health services to support students and families at eight elementary schools in which at least 80% of students were eligible to participate in the Free and Reduced-price Meals Program during the 2017-2018 school year.

SUMMARY OF KEY DISCUSSION POINTS

DHHS will provide services and bill MCPS for reimbursement as follows:

- \$126,384 for three School Community Health Nurses (annualized cost of \$303,321) and
- \$231,947 for contractual mental health services (annualized cost of \$556,673).

I am recommending a supplemental appropriation to the FY20 Operating Budget of the Department of Health and Human Services (DHHS) in the amount of \$358,331 for providing services to Montgomery County Public Schools (MCPS) to fulfill requirements of the Maryland Concentration of Poverty School Grant Program. This appropriation will fund three School Community Health Nurses and contractual support for mental health services.

This supplemental appropriation is needed because MCPS received funding from the Maryland State Department of Education for the Concentration of Poverty School Grant Program. MCPS is collaborating with the DHHS to increase somatic and mental health services to support students and families. DHHS will provide services and bill MCPS for reimbursement.

- a. The amount of \$126,384 would support three School Community Health Nurses. The annualized cost for the services will be \$303,321.
- b. The amount of \$231,947 would provide contractual support for mental health services. The annualized cost for the services will be \$556,673.

I recommend that the County Council approve this supplemental appropriation in the amount of \$358,331 and specify the source of funds as Maryland State Department of Education Grant.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY20 Operating Budget appropriation increases for the Department of Health and Human Services:

- 3. This increase is needed because Montgomery County Public Schools received funding from the Maryland State Department of Education for the Concentration of Poverty School Grant Program. Montgomery County Public Schools is collaborating with the Montgomery County Department of Health and Human Services to provide additional school health nurses and to increase somatic and mental health services to support students and families. Montgomery County Department of Health and Human Services will provide services and bill Montgomery County Public Schools for reimbursement.
 - a. The amount of \$126,384 would support three School Community Health Nurses. The annualized cost for the services will be \$303,321.
 - b. The amount of \$231,947 would provide contractual support for mental health services. The annualized cost for the services will be \$556,673.
- 4. The County Executive recommends a supplemental appropriation to the FY20 Operating Budget in the amount of \$358,331 for three School Community Health Nurses and contractual support for mental health services and specifies that the source of funds is Maryland State Department of Education Grant.
- 5. Notice of public hearing was given, and a public hearing was held.

Background

Senate Bill 1030, The Blueprint for Maryland's Future, established the Concentration of Poverty Grant Program to help ensure all students meet challenging state academic standards. Specifically, the program provides financial assistance for community supports and wraparound services to local educational agencies and schools with high numbers or percentages of students from low-income families. Schools in which at least 80 percent of students were eligible to participate in the Free and Reduced-price Meals Program during the 2017–2018 school year are eligible to receive funding. For Fiscal Year 2020, Montgomery County Public Schools (MCPS) has been awarded \$1,990,664 to coordinate and provide services for students and families at eight schools that met the criteria (Attachment).

Based on the guidelines set forth by the Maryland State Department of Education (MSDE), each identified school is required to employ a staff member to serve as a community school liaison to work with school teams, community agencies, families, and stakeholders to complete a comprehensive needs assessment and strategic plan for expanding educational opportunities and wraparound services. In addition, schools without a full-time school community health nurse, five days per week, are required to increase hours to provide healthcare coverage while students are in school. Those schools that currently do not have a school-based health center have to use funding to increase healthcare services. With the remaining funds, schools are able to increase mental health support, somatic health care, and other wraparound services designed to increase attendance, engagement, achievement, and health and wellness. MCPS is collaborating with the Montgomery County Department of Health and Human Services (DHHS) to provide additional somatic and mental health care services, through School Health Services and Linkages to Learning, respectively.

An initial meeting was held on July 23, 2019, with DHHS staff members and principals of the eight schools at which time Senate Bill 1030 was discussed and the implications for schools was presented. With the expectations set forth in Senate Bill 1030, principals met with their leadership teams and community stakeholders to determine how to support students and families. In late September, principals submitted their spending plans which specified staffing needs (i.e., school community liaison, healthcare providers, and mental health providers), as well as the wraparound services to promote student success. Examples of the wraparound services include vision and dental care, and supports to improve school attendance. In early October, the chief financial officer and chief

academic officer reviewed and approved all spending plans and hiring for the community school liaisons, community health nurses and mental health providers began. The attachment includes details
