DESCRIPTION/ISSUE

The County Council will hold a public hearing and consider action on a supplemental appropriation to the FY20 Capital Budget and Amendment to the FY19-24 Capital Improvements Program, Montgomery County Public Schools, \$367,850 for the HVAC (Mechanical Systems) Replacement: MCPS Project. The source of funds is State Aid.

SUMMARY OF KEY DISCUSSION POINTS

- The Board of Education requested this supplemental appropriation and CIP amendment on January 9. The County Executive recommended approval on February 4. The Council introduced the supplemental appropriation and CIP amendment on February 25.
- This supplemental appropriation is needed because MCPS received funding from the State of Maryland Healthy Schools Fund for HVAC improvements in schools.

Amendment to the FY19-24 Capital Improvements Program and SUBJECT: Supplemental Appropriation 21-S20-CMCPS-5 to the FY20 Capital Budget Montgomery County Public Schools HVAC (Mechanical Systems) Replacement: MCPS (No. P816633), \$367,850

I am recommending an Amendment to the FY19-24 Capital Improvements Program and a Supplemental Appropriation to the FY20 Capital Budget in the amount of \$367,850 for the HVAC (Mechanical Systems) Replacement: MCPS (No. P816633) capital project. This supplemental appropriation is from the Maryland's Healthy Schools Facility Fund to improve environmental health conditions in Montgomery County Public Schools (MCPS) school buildings.

This increase is needed because the Healthy Schools Facility Fund program funds from the State of Maryland leverage non-County funding for capital improvements, repairs, maintenance, and deferred maintenance of existing school buildings. In FY20, MCPS will add \$367,850 to the HVAC (Mechanical Systems) Replacement: MCPS (No P816633) and use these State Aid funds.

The Healthy Schools Facility Fund program was established in calendar year 2018 to improve the conditions related to air conditioning, heating, indoor air quality, mold remediation, temperature regulation, plumbing (including the presence of lead in drinking water outlets), and windows. The State requires that MCPS' projects approved under this program are completed before reimbursement can occur. For this reason, I recommend that the County Council approve this Amendment to the FY19-24 Capital Improvements Program and a Supplemental Appropriation in the amount of \$367,850 and specify the source of funds as State Aid.

I appreciate your prompt consideration of this action.

Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. Section 302 of the Montgomery County Charter provides that the Council may amend an approved capital improvements program at any time by an affirmative vote of no fewer than six members of the Council.
- 3. The Board of Education requested a supplemental appropriation in FY20 for the HVAC (Mechanical Systems) Replacement: MCPS (P816633) capital project as follows:



HVAC (Mechanical Systems) Replacement: MCPS

PROJECT DESCRIPTION

(P816633)

This project provides for the systematic replacement of heating, ventilating, air conditioning, automated temperature controls, and plumbing systems for MCPS facilities. This replacement approach is based on indoor environmental quality (IEQ), energy performance, maintenance data, and the revitalization/expansion schedule. Qualifying systems and/or components are selected based on the above criteria and are prioritized within the CIP through a rating system formula. MCPS is participating in interagency planning and review to share successful and cost effective approaches. For projects on the revitalization/expansion schedule, the scope is reduced to the minimum necessary to maintain the operation of the existing mechanical system. Any new equipment installations will be salvaged at the time of the revitalization/expansion project and will be re-used. An FY 2017 appropriation was approved, but was \$3 million less than the Board of Education's request. The funds will be used for mechanical systems upgrades and/or replacements at John T. Baker (Phase I) and Silver Spring International middle schools; and Greencastle, Olney, Greenwood, Jones Lane, Stone Mill, Brooke Grove, Clearspring, Laytonsville, New Hampshire Estates, and Sligo Creek elementary schools. An FY 2018 appropriation was approved for mechanical systems upgrades and/or replacements at John T. Baker (Phase II), Briggs Chaney (Phase I), and Silver Spring International middle schools; and Jones Lane, Lois P. Rockwell, and Stone Mill elementary schools. An FY 2019 appropriation was requested for mechanical systems upgrades and/or replacements for Ashburton, Bethesda, Burtonsville, Flower Hill, Forest Knolls, Highland View, Monocacy, Oakland Terrace, and Sequoyah elementary schools; Briggs Chaney and White Oak middle schools; and, Quince Orchard and Walt Whitman high schools. However, due to fiscal constraints, the County Council reduced the FY 2019 appropriation by \$4 million. Therefore, the list shown above will be aligned with the approved funding level for FY 2019. The Indoor Air Quality and Energy Conservation projects are now merged with this project to better reflect the coordination of work performed. The workyears reflected in this project are from that merger. An FY 2020 appropriation was approved to continue this level of effort project to address mechanical system upgrades and/or replacements of systems at various schools throughout MCPS.

Background

The state of Maryland's Healthy Schools Facility Fund was established as a new program by legislation in calendar year 2018 through the enactment of Senate Bill 611. This grant provides Local Educational Agencies with funds for projects that will improve environmental health in school facilities. Education Article §5-322, Annotated Code of Maryland, requires the Interagency Commission on School Construction (IAC) to administer the grant, approve expenditures, and develop administrative procedures for the grant program.

The Healthy School Facility Fund will provide grants to public primary and secondary schools for capital projects that will improve the health of school facilities. This includes projects that will improve the conditions related to air conditioning, heating, indoor air quality, mold remediation, temperature regulation, plumbing (including the presence of lead in drinking water outlets in school buildings), and windows. IAC prioritized projects from the grant that correct issues posing an immediate life, safety, or health threat to occupants of a facility.

On October 16, 2019, Montgomery County Public Schools received confirmation from the IAC regarding our Fiscal Year 2020 Healthy Schools Facility Fund. All projects submitted statewide were prioritized and evaluated based on the severity of the life, safety, and health deficiency. As a result of the prioritization and the funding formula, the eligible allocation for MCPS is \$367,850. MCPS did submit more project requests than were recommended for funding; however, those projects were identified as deferred.

WHEREAS, On October 16, 2019, Montgomery County Public Schools was informed by the state of Maryland Interagency Commission on School Construction of the recommended allocation from the Healthy Schools Facility Fund; and WHEREAS, The Interagency Commission on School Construction approved \$367,850 for Montgomery County Public Schools for the projects submitted; and

WHEREAS, The state of Maryland Interagency Commission on School Construction requires that the approved Healthy Schools Facility Fund projects be completed before reimbursement can occur; and

WHEREAS, A supplemental appropriation from the Montgomery County Council is required to forward fund the projects; and

WHEREAS, The state of Maryland Interagency Commission on School Construction will reimburse Montgomery County once the projects are complete; now therefore be it

<u>Resolved.</u> That the Board of Education request a Fiscal Year 2020 supplemental appropriation and amendment to the Fiscal Year 2019-2024 Capital Improvements Program in the amount of \$367,850 to fund eligible projects in the Healthy Schools Facility Fund; and be it further

<u>Resolved</u>. That a copy of this resolution be forwarded to the county executive and County Council; and be it further

<u>Resolved</u>. That the county executive be requested to recommend approval of this resolution to the County Council.
