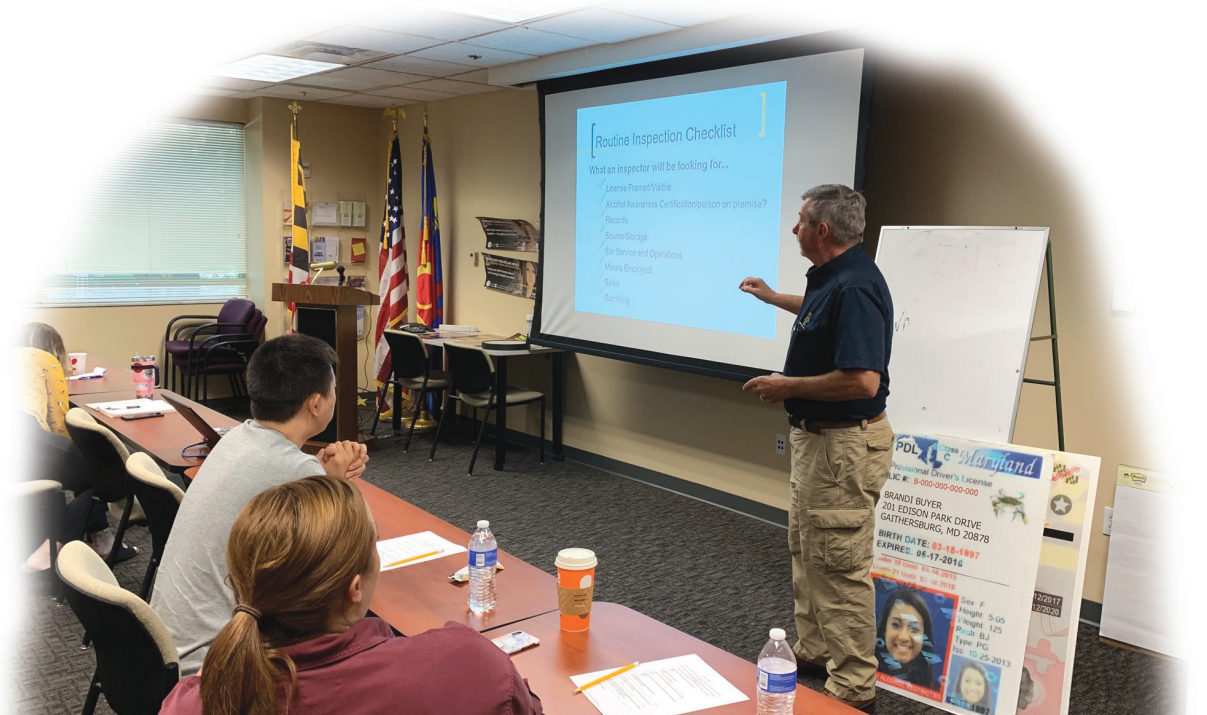

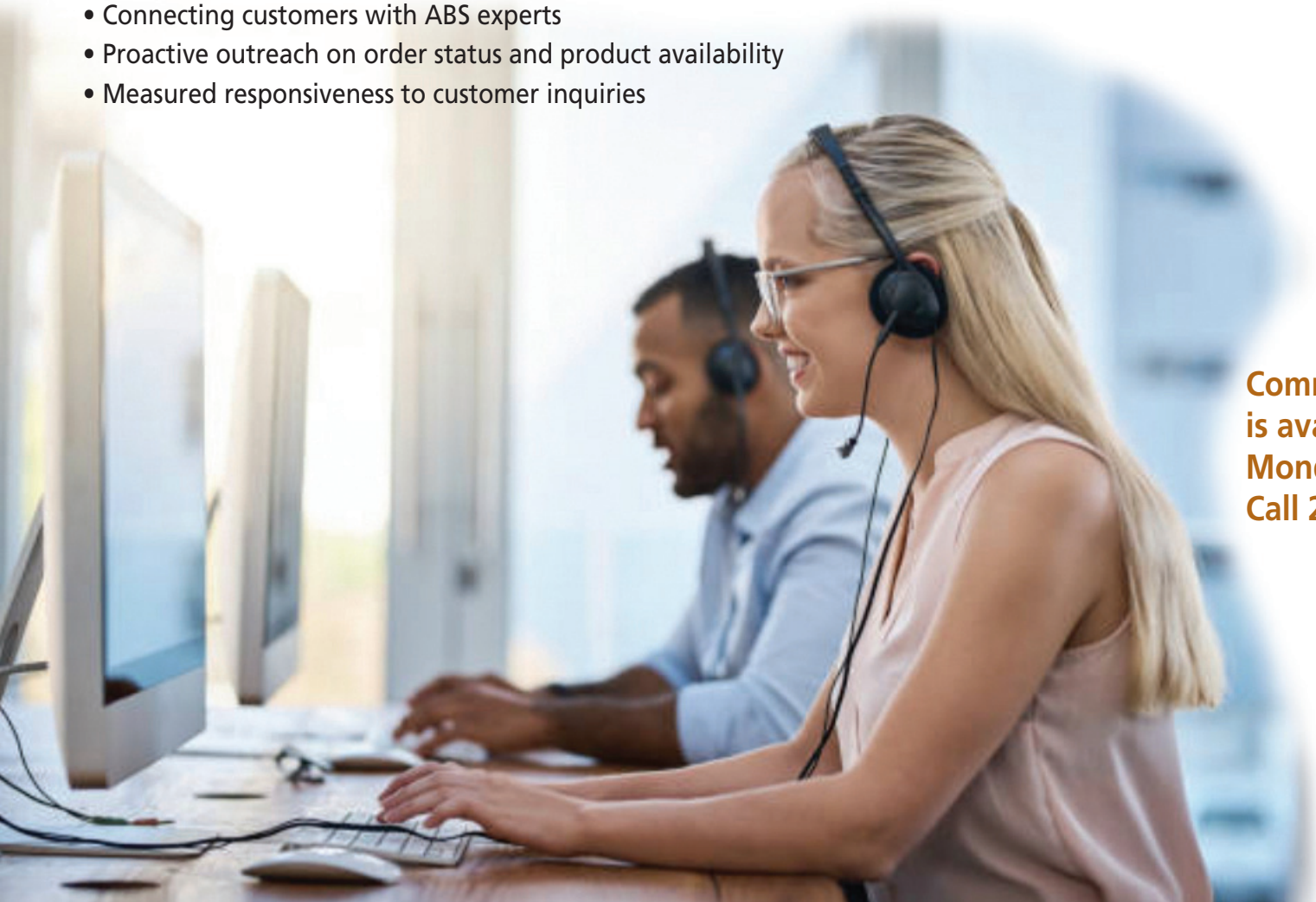

OUTDOOR CAFES

Requirements

- Landlord approval is required
- Contiguous to the licensed premises, enclosed in a clearly delineated area, and surrounded by a continuous barrier at least 36 inches high at its lowest point of ingress and egress; and neither on any public property nor on a public right-of-way, without the express written approval of the appropriate state, county or local governmental authority.
- On the same side of the street and extends no more than a combined total of fifty (50) feet beyond the width of the store front.
- If a public walkway exists the distance between the store front of the licensed premises and the closest point of the café area must be no more than 25 feet; and enclosed in a clearly delineated area, and surrounded by a continuous barrier at least 36 inches high at its lowest point with controlled point(s) of entrance and exit.
- Wait service must be available for the outdoor café if not contiguous to the building.

LOCAL MANUFACTURERS

The State of Maryland allows small wineries, breweries and distilleries to self-distribute in Montgomery County and throughout the state of Maryland. The manufacturer must be licensed to self-distribute through the Maryland Comptroller's Office.

Wine

Licensed establishments are allowed to purchase wine directly from an in-state Maryland winery that holds a class 6 limited wine wholesale license and out-of-state wineries that hold a non-resident winery permit.

Microbrews

Licensed establishments can purchase microbrews directly from an in-state Maryland brewery that holds the class 7 limited beer wholesale license and out-of-state breweries that hold a non-resident brewery permit.

Spirits

Licensed establishments are allowed to purchase spirits directly from an in-state Maryland distillery that holds a class 8 limited liquor wholesalers license and out-of-state distilleries with a non-resident distillery permit.

INSPECTIONS

The Division of Licensure, Education and Regulation conducts the following inspections of licensees on regular basis:

1. Underage Sales

Sale/Service of alcohol to patrons under 21.

2. Training

Alcohol Awareness Training. A certified person must be on the licensed premises at all times it is open to the public.

3. After Hours

No alcoholic beverages may be sold, dispensed, consumed on premises after the hours posted on the license.

4. No Food Available

Food must be available at all times alcohol is offered for sale.

5. Source/Storage

Unapproved Source/Storage. No establishment shall sell, store, or keep any alcoholic beverages on the licensed premises except those purchased from ABS or self-distributing breweries, wineries or distilleries. Keep all receipts for two years.

- Before hiring a promoter, consider the risks involved as licensees will be held responsible for anything that occurs on the licensed premises. Protect yourself by developing responsible policies for your staff and guests.

- Only holders of a Class B or Class BD Beer, Wine and Liquor License with a Catering Permit may serve alcohol at an off-premises catered event or at a community festival. Apply at MontgomeryCountyMD.gov/ABS/Resources

- Temporary alterations to the licensed premises, such as reconfiguring the furniture or adding an outdoor tent, require a Temporary Business Modification authority. Apply at MontgomeryCountyMD.gov/abs/licensure/eforms

RESPONSIBLE SERVICE

Responsible Policies:

- Refuse service to those who appear intoxicated
- Avoid promotions that encourage over-consumption
- Have a written policy listing step-by-step instructions on what a server should do if a patron becomes intoxicated
- Train staff
- Encourage food sales and nonalcoholic drinks. Place a glass of water down, without asking, to accompany the first alcoholic drink
- Publicize alcohol policies in visible locations
- Do not allow staff to consume alcohol while working

Has your business decided to accept vertical IDs?

If you have, make sure your staff is thoroughly trained on how to read the information on the ID to ensure compliance.



Wondering about CBD?

The use of cannabidiols (CBD) as a food additive in Maryland has not been approved by either the U.S. Food and Drug Administration (FDA) or the Maryland Department of Health. Food and beverages that have either been made with CBD, or in which CBD has been added in any way, are considered adulterated and are not to be used, sold, or served.
