Briefing: State's Attorney's Office Crime Prevention Initiatives

PURPOSE:

To receive information on the various prevention programs within the State's

Attorney's Office.

Today the Committee will receive a briefing from the SAO. Those expected to brief the Committee:

The State's Attorney's Office runs or participates in a variety of programs focused on diversion. These programs focus on alternatives to prosecution, school-based programs, and community outreach. In addition, certain office policies such as the de-criminalization of marijuana assist in diverting individuals from the criminal justice system, and instead focus on providing support and educational services that help individuals avoid crime.

Alternatives to Prosecution

The State's Attorney's program participates in a variety of programs designed to prevent crime without prosecuting the individual.

- Alternative Community Service (ACS) is a program for first-time adult offenders
 who have been charged with misdemeanor crimes or civil citations. In exchange
 for successful completion of community service, an individual's case is not
 prosecuted.
- Intervention Program for Substance Abusers (IPSA) provides treatment, education, and monitoring for individuals charged with some misdemeanor drug and criminal drug citation cases.

- Adult Drug Court is a voluntary drug treatment program that also permits a successful participant to avoid prosecution.
- Mental health Court provides an intensive mental health treatment program for individuals charged with certain crimes.
- Mediation services are also provided by the SAO that provide an alternative way to resolve certain criminal charges or non-physical domestic disputes.

School-Based Programs

The SAO has several youth-based programs that help provide support and education for kids to help them learn positive behaviors and skills.

- The Choose Respect initiative promotes information about health relationships and provides awareness of teen dating violence.
- Teen Court is a program for first-time juvenile offenders, who are adjudicated by teen volunteer jurors. Teen court determinations could result in community service, apology essays, additional education, or other similar approaches.
- Cluster projects allows the SAO to partner with other stakeholders to provide support for students of color and assist with closing the academic achievement gap.
- The Truancy Prevention Program provides early intervention to middle school students, to identify and assist with the root causes of truancy.
- The MCPS Cyber Safety program educates students and parents about online risks and teaches appropriate safety measures.
- The Students Accessing Opportunities Summer Academy was new this year and provided a free four-day summer camp to learn about criminal justice.

Community Outreach

The SAO also provides community outreach in a variety of ways.

- The SAO provides Domestic Violence awareness, public outreach and training activities. The office also assists in training prosecutors and police in various aspects of domestic violence and related issues.
- The SAO provides community education on the opioid epidemi, Narcan use, as well as Maryland's good Samaritan Law.
- Senior Community Outreach programs address abuse, neglect, and exploitation of seniors, and provides tips to seniors on how to avoid such things as online or telephone scams.
- The SAO also participates in National Night Out, an annual event that helps foster good police-community relationships.

Discussion Issues

- 1. Several of your programs, like the Truancy Prevention Program, rely heavily on volunteer participation. Volunteerism in general, however, has been declining nationally. Have you had challenges recruiting volunteers for your various programs?
- 2. Do you have any identified areas where diversion programs could be expanded, or see other program opportunities that help prevent crime?
- 3. Are there particular programs where additional staff are needed?

Office Policies

Pre-Decriminalization Marijuana Possession Policy

SAO marijuana possession policy had uniform support from all Montgomery County Police chiefs.

Policy has saved money on police overtime and county crime lab drug-testing costs.

Marijuana Distribution Policy

- Police may request special exemption from policy where extenuating circumstances present
- Exemption factors include:
 - Prior criminal history
 - Community impact created by the defendant's distribution
 - Use or possession of a handgun involved
 - Evidence and strength of State's case

Discretionary Prosecution: Pre-Trial

SAO always looks to equitable relief.

For non-violent misdemeanors, charges may be fashioned to reduce likelihood of deportation.

Determination based on evaluation of individuals' specific circumstances.

Discretionary Prosecution: Post-Conviction

After a finding of guilt, if collateral attack is made on prior conviction specific to marijuana, SAO will consent to relief.

Alternatives to Prosecution

Alternative Community Service (ACS)

- Community service for first-time adult offenders charged with misdemeanor offenses or civil citations.
 - E.g. shoplifting, trespassing
- Expungement assistance for eligible cases.

Intervention Program for Substance Abusers (IPSA)

- For offenders with moderate substance abuse problems and limited criminal histories.
- Diversion for misdemeanor drug cases and criminal drug citation cases.
- Requirements include:
 - Drug education classes
 - Community service
 - Remain clean for duration with possible drug testing

Adult Drug Court

SAO program partners: Public Defender's Office, HHS (Addiction Services; Behavioral Health and Crises Services), Dept. Of Corrections (Pre-Release Services), MCCF, Second Chance Addiction Care, Maryland Wellness & Recovery

Drug Court

- Voluntary program with intensive services and supervision for substance dependence
- 33-month duration on average
- 440 participants since 2006, 94 currently enrolled
- 31% recidivism (local arrests and convictions only)

Intervention Track

- Started May 2019
 - · Seven enrolled, more awaiting screening
- Eligibility: (i) under 7 criminal convictions, or (ii) 3 DUI convictions
 - Offers more supervision than probation (case manager, therapist, weekly court visit)
- Opiate addicts with possession charges
 - IPSA not intense enough for opiate addiction
- Repeat DUI offenders
 - 4 DUI convictions shows addiction, need for treatment

Mental Health Court

SAO program partners: Public defender's Office, HHS (Forensic services), county judiciary

District Court Program

- 75 participant capacity
 - · 56 current participants
 - 29 graduates since Jan. 2017
 - · 2 reoffenders, both readmitted
 - 5-8 anticipated graduates on 10/18
- Full-time Dept. of Health staff member
 - · Hospital coordination
 - · Develops aftercare plans and housing

Circuit Court Program

- 25 participant capacity
- Average 18-month duration
 - Multiple phases for completion, each several months long
- Participants enrolled upon approval, not as a class
 - 12 current participants
 - 2 graduates since Dec. 2017
- · No terminations for new offences
 - Some participants removed from courtbased program to hospital-based treatment

Mediation

- Voluntary, confidential, and collaborative process with neutral arbitrator helping find a win-win solution to participant conflicts.
- Alternative means of resolving
 - Criminal charges before trial (trespass, telephone abuse, malicious destruction of property, assault, etc.)
 - Non-physical domestic disputes resulting in criminal activity
 - Incidents of neighbor disagreements or community disputes




- "Expect Respect" Presentation
 - MCPS-approved presentation for students
 - Focus on healthy relationships, teen dating violence awareness
- Special programs for Athletes
 - Coaching Boys into Men: Equips coaches to teach athletes that violence never equal strength
 - Athletes as Leaders: Empowers female athletes to take active role in promoting health relationships and ending sexual violence.



Teen Court

SAO program partners: HHS (Screening and Assessment Services for Children and Adolescents), Montgomery County Judiciary, members of the public

- · For first-time juvenile offenders
 - Charge dismissed with successful completion
- 2016-18: 709 case referrals, 619 accepted (87%)
 - 497 (80%) successful
 - 122 (20%) unsuccessful:
 - 27 (22%) incomplete TC disposition
 - 12 (10%) SASCA non-compliant
 - 73 (60%) SASCA and TC noncompliant
 - 10 (8%) reoffended



Cluster Projects

SAO program partners: MCPS, Collaboration Council, HHS, Recreation Dept., MCPD, Maryland Dept. of Juvenile Services

- Closing academic achievement gap for minority students through:
 - Multi-Agency Team Process
 - Out-of-school-time activities
 - Community partnerships
- Brings all agencies together to provide services faster and easier.
 - Clear, timely communication between agencies
 - Avoids run around to multiple locations

Truancy Prevention Program

SAO program partners: MCPS, Community volunteers

- Early intervention program to identify and address root causes of truancy.
- Ten weekly meetings to address students' strengths and weaknesses.
- Data-driven, targeted student selection.
 - 10 students with 10-20% unexcused absences previous semester

MCPS Internet Safety Training

- 300 presentations since 2015
 - 10,000+ student audience
 - 1,000+ parents (PTA and MCPS Parent Academy)
- Internet safety now built into MCPS health curriculum




Middle and High School Presentation

Students Accessing Opportunities (SAO) Summer Academy

SAO program partners: SASCA, MCPD & Sheriff's Office, County Judiciary, Family Justice Center

- Free four-day program hosted by SAO.
 - Two sessions each for middle and high schoolers
 - · Free lunch provided
- · Presentations and activities.
 - E.g. Mock trial, Choose Respect, cyber safety, financial literacy, college/career readiness, K9 Units.
- · Location difficult for some students.
 - Will host sessions across county for wider access

Domestic Violence Awareness: Public Outreach

SAO program partners: HHS (Crisis Services), Commission for Women, MCPD, Board of Education, Dept. of Corrections (Pre-Release Services), county judiciary, MD Dept. of Public Safety

- Partner of Domestic Violence Coordinating Council.
- 2018: Designated February as Teen Dating Violence Awareness Month.
 - Tweeted messages about dating violence
- 2017: Countywide domestic violence and education campaign.
 - 28 exterior bus signs in English and Spanish
 - 15 bus shelter signs
 - Banner ads on social media pages, County digital screens, and County Rotator

Domestic Violence Awareness: Training

SAO program partners: Maryland State's Attorney's Association, National District Attorney's Association, US Department of State

Awareness Initiatives

- Education and outreach bus sign campaign
