- SUBJECT: **Public Hearing:** Special appropriation to the Montgomery County Public Schools FY19 Capital Budget - \$5.0 million for <u>Relocatable Classrooms</u> (Source: Current Revenue)¹
- PURPOSE: To receive testimony regarding the Board of Education's requested special appropriation request for Relocatable Classrooms.

Background

On March 8, the Council received the Board of Education's special appropriation request for 5.0 million for the leasing, purchase, movement, and rehabilitation of relocatable classrooms needed for the 2019-20 school year (see 3-5). A draft resolution is attached on 1-2.

MCPS' request would accelerate \$5.0 million in current revenue-funded requested appropriation from FY20 to FY19 to allow MCPS to move forward with contractual work this spring, so that the relocatable classrooms can be ready by the start of the 2019-20 school year. The expenditures related to the appropriation would still occur in FY20.

Within the Approved FY19-24 CIP, the <u>Relocatable Classrooms</u> project already includes \$5.0 million in expenditures in FY20, so the special appropriation request does not involve an expenditure change for the project.

On March 15, the County Executive transmitted his recommendation to approve the request (see @6-10). His recommendation assumes utilizing \$1.731 million in Recordation Tax revenue and \$3.269 million in Current Revenue: General.

A Transportation & Environment Committee worksession is tentatively scheduled for April 8.

Background

- 1. Article 3, Section 308 of the Charter of Montgomery County, Maryland provides that a special appropriation: (a) may be made at any time after public notice by news release to meet an unforeseen disaster or other emergency, or to act without delay in the public interest; (b) must specify the revenues to finance it; and (c) must be approved by no fewer than six members of the Council.
- 2. The Board of Education requested a special appropriation for the Montgomery County Public Schools' Relocatable Classrooms capital project as follows:

- 3. The special appropriation will allow MCPS to begin contracting work related to Approved FY20 Capital Budget expenditures during FY19 so that new and existing relocatable classrooms can be moved early in the summer of 2019 and be ready for use for the 2019-20 schoolyear.
- 4. Notice of public hearing was given, and a public hearing was held on April 2, 2019.
- 5. The County Council declares this request is in the public interest, to be acted upon without delay, as provided for under special appropriation requirements described in Article 3, Section 308 of the Montgomery County Charter.

PROJECT DESCRIPTION

Unencumbered Balance

For the 2015-2016 school year, MCPS has a total of 500 relocatable classrooms. Of the 500 relocatables, 381 are used to address over utilization at various schools throughout the system. The balance, 119 relocatables, are used to provide daycare at schools, are used at schools undergoing construction projects on-site, or at holding schools, or for other uses countywide. Units around 15-20 years old require general renovation if they are to continue in use as educational spaces. An FY 2015 supplemental appropriation of \$5.0 million was approved to accelerate the FY 2016 appropriation requested by the Board of Education to enter into contracts in order to have relocatables ready for the 2015-2016 school year. An FY 2016 supplemental appropriation of \$2.250 was approved to accelerate the FY 2017 appropriation requested by the Board of Education to enter into contracts in order to have relocatables ready for the 2015-2016 school year. An FY 2016 supplemental appropriation of \$2.250 was approved to accelerate the FY 2017 appropriation requested by the Board of Education to enter into contracts in order to have relocatables ready for the 2015-2016 school year. Background

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. Section 302 of the Montgomery County Charter provides that the Council may amend an approved capital improvements program at any time by an affirmative vote of no fewer than six members of the Council.
- 3. The County Executive recommends the following capital project appropriation increases:
