## **DESCRIPTION/ISSUE**

The County Council will hold a public hearing and consider action on a supplemental appropriation to the FY19 Operating Budget, Montgomery County Public Schools in the amount of \$541,837 for the Heroin and Opioid Prevention Grant. The source of funds is a Maryland State Department of Education (MSDE) Grant.

#### **SUMMARY OF KEY DISCUSSION POINTS**

- The Board of Education requested this appropriation on April 29. The County Executive recommended approval on May 10. The Council introduced this supplemental appropriation on May 15.
- In FY19, the Governor included an appropriation of funds for MSDE to award grants to local school systems to implement policy and conduct training for heroin and opioid addiction. MCPS received an award under this program, and funding will be used for student, family, and community education and awareness. As a grant award, there is no effect on the County's current or future maintenance of effort requirements.

# **Background**

- 1. Section 307 of the Montgomery County Charter provides that any supplemental appropriation shall be recommended by the County Executive who shall specify the source of funds to finance it. The Council shall hold a public hearing on each proposed supplemental appropriation after at least one week's notice. A supplemental appropriation that would comply with, avail the County of, or put into effect a grant or a Federal, State or County law or regulation, or one that is approved after January 1 of any fiscal year, requires an affirmative vote of five Councilmembers. A supplemental appropriation for any other purpose that is approved before January 1 of any fiscal year requires an affirmative vote of six Councilmembers. The Council may, in a single action, approve more than one supplemental appropriation. The Executive may disapprove or reduce a supplemental appropriation, and the Council may reapprove the appropriation, as if it were an item in the annual budget.
- 2. The County Executive has requested the following FY19 Operating Budget appropriation increases for Montgomery County Public Schools

- 3. This increase is needed to provide spending authority for the use of grant funds received from the Maryland State Department of Education. This appropriation will provide students, their families, and the community with training, information and resources on substance abuse through training, workshops, a public awareness campaign, and Narcan for each school location. As a grant award, there is no effect on the County's current or future maintenance of effort requirements.
- 4. The County Executive recommends a supplemental appropriation to the FY19 Operating Budget in the amount of \$541,837 for the Heroin and Opioid Prevention Grant and specifies that the source of funds will be grant funds from the Maryland State Department of Education.
- 5. Notice of public hearing was given, and a public hearing was held.

### Recommendation in Brief

Authorization is requested to receive and expend, subject to County Council approval, a Fiscal Year (FY) 2019 supplemental appropriation of \$541,837 from the Maryland State Department of Education (MSDE) for the Heroin and Opioid Prevention grant.

### Background

In FY 2019, Governor Larry Hogan included an appropriation of funds for MSDE for the purpose of awarding grants to local school systems to implement policy and conduct training for Heroin and Opioid addiction. MCPS received an award from MSDE under this program. Funding will be used for student, family, and community education and awareness. Contractual services for The Botvin Lifeskills Training Program will be purchased for the purpose to teach students in elementary, middle, and high schools the skills they need to navigate life's challenges and to effectively manage stress. Research on the Botvin Lifeskills Training Program has demonstrated long-term effects on reducing youth substance use, as well as decreasing aggressive and delinquent behavior. Botvin Lifeskills Training also includes parent/guardian education and workshops. Funding will be used to bring in speakers to present up-to-date information and resources on substance use to students, families, and staff members. In addition, funding will be used to purchase Narcan for each school location plus maintain a replacement supply in the event of use. Funding also will be used to relaunch a public awareness campaign that was piloted in 2018. Resources, the website, and posters will be updated to be more user-friendly and appealing to youth. This public awareness campaign will target movie theaters. public service announcements on buses, and informational posters for distribution in schools and the community.



## Support of Board of Education Mission

The Heroin and Opioid Policy Development grant is supported by the District Implementation Plan for the Strategic Priorities—Social/Psychological Well-being. This policy supports the acquisition of knowledge, attitudes, and skills necessary to understand personal health and wellness, manage emotions, establish and maintain positive relationships, and make responsible decisions. The Heroin and Opioid Policy Development grant will enable MCPS to intensify efforts to support students and families in both the prevention of and recovery from addiction.
