## **DESCRIPTION/ISSUE**

The County Council will hold a public hearing and consider action on a special appropriation to the FY19 Operating Budget, Montgomery County Public Schools in the amount of \$3,978,197 for the Title I-Part A Grant. The source of funds is a Maryland State Department of Education Grant.

## SUMMARY OF KEY DISCUSSION POINTS

- The Board of Education requested this appropriation on March 25. A draft appropriation resolution is attached. The Council introduced this special appropriation on May 15.
- Montgomery County Public Schools has received notice from the Maryland State Department of Education (MSDE) that it will receive \$29,102,789 for the Title I-Part A grant in FY19, which is \$3,978,197 more than the amount included in the approved FY19 Operating Budget.
- This appropriation is needed to provide MCPS spending authority for the use of grant funds from MSDE. As a grant award, there is no effect on the County's current or future maintenance of effort requirements.
- Council staff recommends approval.

## **Recommendation in Brief**

Authorization is requested to receive and expend, subject to County Council approval, a Fiscal Year (FY) 2019 supplemental appropriation of \$3,978,197 for the Title I-Part A Grant. Montgomery County Public Schools (MCPS) has been awarded \$29,102,789 for the FY 2019 Title I-Part A grant from the Maryland State Department of Education (MSDE), which is \$3,978,197 more than the amount included in MCPS' FY 2019 Operating Budget.

## Background

The purpose of the Title I-Part A grant is to provide financial assistance to local educational agencies and schools with high numbers or high percentages of students from low-income families to help ensure that all students meet challenging state academic standards. Schools in which students from low-income families comprise at least 40 percent of enrollment are eligible to use Title I funds to operate schoolwide programs that serve all students in the school in order to raise the achievement of the lowest-achieving students.

# Support of Board of Education Mission

The Title I-Part A grant benefits students from low income families who are failing or are most at risk of failing, to meet challenging state academic standards. This grant is fully supported by the mission of the Board of Education: every student will have the academic, creative problem solving and social emotional skills to be successful in college and career. ### **Use of Funds**

Funds will be used to provide for:

- Professional part-time salaries;
- Associated employee benefits;
- Instructional materials; and
- Student transportation.

#### **Background**

- 1. Section 308 of the County Charter provides that a special appropriation is an appropriation which states that it is necessary to meet an unforeseen disaster or other emergency, or to act without delay in the public interest. Each special appropriation shall be approved by not less than six Councilmembers. The Council may approve a special appropriation at any time after public notice by news release. Each special appropriation shall specify the source of funds to finance it.
- 2. The Board of Education has requested a special appropriation of \$3,978,197 for the Montgomery County Public Schools' FY19 Operating Budget for the Tittle I Part A Grant from the Maryland State Department of Education:
