PURPOSE: Public Hearing/Action – Council vote required¹

Expedited Bill 17-20, Carryout Bag Tax – Suspension, sponsored by Lead Sponsor Councilmember Jawando and Co-Sponsors Councilmembers Rice and Albornoz, Council President Katz, and Councilmembers Riemer, Navarro and Friedson was introduced on March 31. A public hearing is scheduled for April 14; Council action is tentatively scheduled immediately following the public hearing.

On March 5, 2020, Lawrence Hogan, Jr., Governor of Maryland issued a proclamation declaring a state of emergency and existence of a catastrophic public health emergency due to the novel coronavirus which can cause the respiratory disease COVID-19.

Expedited Bill 17-20 would suspend the imposition of the carryout bag tax until 15 days after the conclusion of the Maryland state of emergency. Within 7 days after the state of emergency ceases, Bill 17-20 would require the County Executive to notify retail establishments and the public of the date on which the imposition of the carryout bag tax will resume.

Correspondence Received

The Council has received correspondence from residents that support and oppose Bill 17-20. The Maryland Retailers Association submitted a letter in support of Bill 17-20 (©7-8). Those that support Bill 17-20 generally agree that using reusable bags during this public health emergency is concerning (©5-11). Residents that oppose Bill 17-20 express concerns related to the environment (©12-18).

Rice Amendment

At the appropriate time, Councilmember Rice intends to offer the amendment on ©19 which would state that:

During the state of emergency and during the 15 days after the state of emergency ceases, an employee of a retail establishment must not be required to place purchases in any container, including a reusable bag, that a customer provides.

Re: Bill xx-20, Carry-out Bag Tax Suspension

Covid-19 has caused a myriad of issues in our community that affect residents from all walks of life. Social distancing and limiting contact in public places, person to person as well as the surfaces we touch, are key to reducing the spread of the virus.

I am introducing Bill xx-20, Carry-out Bag Tax Suspension as an Expedited Act during the Covid-19 pandemic. Some retail establishments, including some grocery stores, are currently prohibiting customers from using their personal reusable bags in stores. It is possible that more establishments will adopt the same policy soon. Handling reusable bags presents a potential public health risk to those employees who must bag items for customers, as well as to the customers themselves. Suspending the carry-out bag tax during the Covid-19 pandemic allows store bags to be used at no charge to customers which will hopefully minimize risk.

Bill xx-20 suspends the carryout bag tax and a retail establishment cannot collect the tax until 15 days after the state of emergency ceases. The County Executive must notify retail establishments and the public of the date that the carryout bag tax will resume within 7 days after the state of emergency for Covid-19 ceases.

While the carryout bag tax does generate some revenue for the County, the health and safety of all Montgomery County residents must come first. Covid-19 represents a threat that has never been seen before and we must act accordingly. I am asking each of my Council colleagues to join me in support of this bill. Thank you.

Dear Council President Sidney Katz and Honorable Members of the Montgomery Council,

On behalf of the Maryland Retailers Association and Maryland Food Industry Council, which represents grocers and various food stores across Maryland, we are in full support of Councilman Will Jawando's legislation temporarily suspending the fee on bags. Retail and grocery employees, much like health care professionals, are on the front lines of providing necessary services during this unprecedented time and we must do everything in our power to protect them. Many of our stores are not allowing consumers to bring in reusable bags which forces consumers into a fee they cannot avoid.

The NIH reported on March 17th of this year, "the virus that causes coronavirus disease 2019 (COVID-19) is stable for several hours to days in aerosols and on surfaces, according to a new study from National Institutes of Health, CDC, UCLA and Princeton University scientists in *The New England Journal of Medicine*. The scientists found that severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) was detectable in aerosols for up to three hours, up to four hours on copper, up to 24 hours on cardboard and up to two to three days on plastic and stainless steel. The results provide key information about the stability of SARS-CoV-2, which causes COVID-19 disease, and suggests that people may acquire the virus through the air and after touching contaminated objects."

The CDC reports that it may be possible that a person can contract COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes. Further points are made below via various studies in the US regarding reusable bags:

- In a 2018 study by the Loma Linda University School of Public Health, researchers sprayed reusable polypropylene grocery bags with a safe norovirus surrogate and asked grocery store customers to shop with the bags. The researchers then swabbed surfaces touched by the shoppers. They found the virus surrogate everywhere on food packages, fresh produce, cart handles, checkout touch screens and checkout clerks. The highest concentrations were on the hands of both the store clerks and the shoppers. Most importantly, "Even the lowest average concentration of virus particles detected on any surface in the study would represent a virus transmission risk for most individuals."
- A study by the University of Arizona found that 51% of all reusable bags contained coliform bacteria, and 12% contained E. coli, indicating the presence of fecal matter and

other pathogens. The same study found that 97% of individuals admitted that they never washed their reusable bags.

- In 2013, millions of American piglets died amid an outbreak of novel swine enteric coronavirus disease, and after an investigation the U.S. Department of Agriculture concluded that reusable feed totes were the most likely root cause. The feed bags are often made of the same kind of material as reusable shopping bags (polypropylene).
- California researchers studying the potential of reusable bags to transmit infectious diseases found that a contaminated reusable bag would cross-contaminate any surface it came into contact with, putting nine out of 10 people who go to that grocery store at risk of infection.

Additionally, due to increased shopping, retailers are unsure at this time about the long-term availability of reusable bags given that most of the permissible bags are only available from overseas manufacturers. Supply for plant-based food trays has also become unpredictable due to global demand and unsteady supply chains due to the global pandemic.

Please know that this request is not taken lightly as MRA worked hard to support legislation establishing a plastic ban and ten cent fee on paper this legislative session. However, we believe it is in the best interest of the thousands of retail employees across the state that have little to no access to personal protective equipment as they repeatedly come in contact with potentially contagious shoppers that Maryland's bans and fees be lifted until the pandemic has subsided.

Numerous states and localities across the country have already moved forward with these suspensions, including New Hampshire, Maine and Massachusetts.

We thank you for your consideration and leadership during this challenging time. We look forward to working with you and your teams to best serve our communities safely and efficiently.

I'd like to talk to you about abandoning the County Bag Tax in light of the COVID19 pandemic. Reuseable bags are a health hazard. They can harbor bacteria and disease for long periods of time, and are rarely if ever washed thoroughly. On a recent trip to my local Safeway I learned that, for the health and safety of their employees, they will no longer bag your groceries if you bring your own bags. I do not think it is wise, helpful, or healthy for Montgomery County Government to continue to impose the Bag Tax on citizens, especially at risk seniors and others with compromised immune systems. Repeal the County plastic bag tax now - here's why.

Recently I wrote to various Council members requesting repeal of the plastic bag tax as a public health measure in the midst of the coronavirus pandemic. As you know, one purpose of the tax was to force County residents to use "recyclable" cloth bags in lieu of plastic. We now learn that the use of other-than-new plastic bags at the grocery store increases the risk of transmission of the coronavirus. Because of this threat, County grocery stores are now refusing to allow their employees to pack groceries into "recyclable" bags. In these circumstances, it is imperative that we do all we can to encourage use of plastic bags at all County business establishments, most especially grocery stores. The easiest, speediest and most effective way to do this is to repeal the County plastic bag tax.

Admittedly that tax is one of the signature items of your Democratic Party's political agenda (there was no citizen groundswell movement for its enactment) and while it hasn't made a noticeable difference in County environment, it has served to fatten County tax coffers, thereby giving you more money to spend. As such, I realize that it will be hard for you to repeal it. Dear Council President,

I was very distressed to hear about a bill that would encourage increased use of single-use plastic bags.

The production, use and disposal of single use plastic bags harms our air, our water, our environment, and even when we can no longer see it, decomposes into microscopic particles which are now found in our water supply that harm our endocrine system. This is why the county greatly restricted the use of plastic bags in the first place.

If plastic bag manufacturers claim that reusable bags can harbor viruses, then how much worse will it be when those 'single use' bags are left on our sidewalks, walking trails and bushes as will certainly occur.

While there's no evidence that reusable bags are a significant source of viral transmission, epidemiologists have identified several steps that can and should be taken by all retail stores that would reduce transmission. These steps, roughly in priority order, are routine in many of the countries and places that have been most successful in reducing the spread of the virus.

- 1. All store employees, and all customers entering the store, should wear masks and gloves. I find it unbelievable that most stores' employees are still not wearing masks even though data suggests that asyptomatic young adults are the likeliest source of transmission. If customers don't have a mask they shouldn't be allowed in. Everyone can make DIY masks. As for gloves, the store should be ready to give them to customers without one as the Grosvenor Market food store has been doing for the last few weeks.
- 2. All stores should constantly be broadcasting a message on the importance for all customers to

keep their social distance from each other.

- 3. Stores should monitor and restrict the # of people in the stores to ensure that they don't get crowded.
- 4. Wherever possible, store aisles should be made one-way to better ensure social distancing.
- 5. The conveyor belt at the cash register and the self check-out surfaces should be wiped with disinfectant after every customer.
- 6. Stores should post signs and make announcements reminding shoppers to clean their reusable bags

If plastic bag manufacturers claim that reusable bags can harbor viruses, then how much worse will it be when those 'single use' bags are left on our sidewalks, walking trails and bushes as they absolutely will. And why is it ok for people to bring their pocket books, back packs and jackets into the store, if its not ok to bring their reusable bags?

While there's no evidence that reusable bags are a significant source of viral transmission, epidemiologists have identified *several steps* that can and should be taken by all retail stores that *would reduce transmission*. These steps, roughly in priority order, are routine in many of the countries and places that have been most successful in reducing the spread of the virus.

1. All store employees, and all customers entering the store, should wear masks and gloves. I find it unbelievable that most stores' employees are still not wearing masks even though data suggests that asyptomatic young adults are the likeliest source of transmission. If customers don't have a mask they shouldn't be allowed in. Everyone can make DIY masks. As for gloves, the store should be ready to give them to customers without one as the Grosvenor Market food store has been doing for the last few weeks.

- 2. All stores should constantly be broadcasting a message on the importance for all customers to keep their social distance from each other.
- 3. Stores should monitor and restrict the # of people in the stores to ensure that they don't get crowded.
- 4. Wherever possible, store aisles should be made one-way to better ensure social distancing.
- 5. The conveyor belt at the cash register and the self check-out surfaces should be wiped with disinfectant after every customer.
- 6. Stores should post signs and make announcements reminding shoppers to clean their reusable bags

As this virus should make absolutely clear to all humans, we are only as healthy as our surrounding environment. The 'sicker' our environment gets the more likely we will gets diseases from that weakened environment whether it be deer ticks, nile virus, H1N1 or now the Corona Virus. This is not the time to make this worse.

To Expedited Bill 17-20

Beginning on page 2, lines 22-23, change Section (b)(4) to read:

4		<u>(B)</u>	During the state of emergency and during the 15 days after
5			the state of emergency ceases, an employee of a retail
6			establishment must not be required to place purchases in any
7			container, including a reusable bag, that a customer
8			<u>provides</u> .
