COUNCIL DECISION POINTS & COMMITTEE RECOMMENDATION

- The Planning, Housing, and Economic Development Committee reviewed the proposed resolution on Monday, June 22, 2020 and made the following recommended amendments to the resolution:
 - a. Amended the fiscal year of the appropriation from FY20 to FY21;
 - b. Amended the Source of Funds from General Fund Reserves to Federal Grant Funds; and
 - c. Amended the appropriation recipient from Maryland Technology Council to the Office of the County Executive, Non-Competitive Contract for the Maryland Technology Council.
- The resolution was updated to reflect that the full Council supported the appropriation.

DESCRIPTION/ISSUE

The subject resolution supports the Maryland Tech Council's creation of a Business Continuity Task Force (BCTF). The BCTF will assist tech and life science entrepreneurs in Maryland that are navigating the economic downturn due to the health crisis. The BCTF includes experienced business leaders who have led businesses through the financial crisis, like the 2008 recession; this team will help small and mid-sized tech and life science businesses plan for an optimal recovery and execute the recovery plan based on the economic conditions following the health crisis.

SUMMARY OF KEY DISCUSSION POINTS

- The BCTF is anticipated to assist 65-80 businesses in the County during the next year.
- The County's appropriation supports staff salary, outreach, and administrative costs to run the program in the County.
- The Maryland Technology Council (MTC) will partner with the County to broadly market this opportunity.

PURPOSE: Discussion and recommendation on special appropriation

The PHED Committee will receive a briefing from the Maryland Technology Council (MTC) about its Business Continuity Task Force. In addition, the committee will review the special appropriation introduced on June 9, 2020 to support this initiative in the County.

I. Business Continuity Task Force

MTC provide details regarding the Business Continuity Task Force (BCTF) on ©1-3. The BCTF will provide technical experience for small- to mid-size tech and life sciences businesses in the County to aid in navigating the economic landscape post-health crisis. The support will include assistance to retain and rehire staff, maintain revenue streams, and access capital. The BCTF includes experienced business leaders, some of whom led businesses through the 2008 recession, to provide technical and operational assistance to businesses to execute a recovery plan.

The Council introduced a \$250,000 FY20 special appropriation to fund this effort in the County (see ©4-6). The funding supports staff salary, outreach, and administrative costs for the program in the County. MTC estimates approximately 65-80 County businesses will receive support based on the \$250,000 funding level. MTC will partner with the County to broadly market this opportunity to small- to mid-sized tech and life science business in the County. The program is anticipated to run for about a year.

II. County Recovery Mission Areas

The Executive created a recovery framework for the County to assess and receive stakeholder input as the County reopens and recovers from the health crisis. One mission area for this recovery framework is “Economic Revitalization.” There are five working groups to the Economic Revitalization as detailed below.

- 1) Advanced Technology and Life Sciences
- 2) Hospitality, Culture, and Entertainment
- 3) Restaurant and Retail
- 4) Small Business
- 5) Workforce Development

Ms. Benjamin is the County facilitator for the Life Sciences and Advanced Technology, and she will be available for today’s discussion to coordinate the County’s effort with MTC and the broader recovery efforts of the County.

Maryland Technology Council Business Continuity Task Force Program Summary

Overview: Small to mid-size businesses (SMBs) typically create more new jobs than large businesses, but also suffer the majority of job destruction or contraction in challenging times. The Maryland Technology Council (MTC) has formed a Business Continuity Task Force (BCTF) equipped to help SMBs navigate the economic downturn caused by the COVID-19 pandemic and help SMBs excel during the economic recovery. The Business Continuity Task Force will focus on life science and technology companies with more than one full-time employee and less than 250. Support and guidance will be provided by highly experienced mentors at no charge to the company, and the term of the engagement will be open to accommodate ongoing needs of the company.

Purpose: The BCTF will help companies maximize their resilience, plan for an optimal recovery, execute the recovery plan and reimagine what the future may look like – ensuring these businesses will have the greatest opportunity to survive the pandemic and thrive afterwards. To maximize the success of the BCTF, the program will leverage the proven policies and principals of the incredibly successful MTC Venture Mentoring Services (MTC VMS) Program. Over the past 5 years, the VMS Program has helped companies raise \$55 million in funding, \$47 million of that for Montgomery County businesses.

Members: Initially, the MTC Business Continuity Task Force is made up of experienced executives that have participated in MTC mentor training programs. The BCTF members have led or guided CEOs and companies through past Black Swan type events such as the 2008 Great Recession or Dot Com Bubble.

Activity: CEOs and company leadership teams may request contact with a member of the Task Force. The initial discovery discussion will focus on the challenges the company is facing. The Task Force Member may provide immediate guidance to the company and refer other specialists to the company for support and assistance. The Task Force Member may also rely on other members of the Task Force to assess those challenges and provide insights as to priority and response. Task Force Members may provide guidance through contractor referrals and introductions to other resources to address challenges and help CEOs and leadership teams examine complex and difficult decisions.

Frederick, Maryland, May 21, 2020 — The **Maryland Tech Council (MTC)** announces today the formation of its [Business Continuity Task Force](#) to assist tech and life science entrepreneurs in Maryland who are navigating the economic downturn due to COVID-19. The MTC Task Force is comprised of experienced business leaders who have led companies through financial crises such as the 2008 Recession. Small to mid-size businesses (SMBs) in the life sciences and technology industries are invited to apply online to be matched with a task force member to receive assistance.

SUBJECT: Special Appropriation to the Fiscal Year 2021 Operating Budget
Office of the County Executive, Non-Competitive Award for the Maryland
Technology Council, Support for COVID-19 Response – Business Continuity
Task Force, \$250,000 (Source of Funds: Federal Grant Funds)

Background

1. Section 308 of the County Charter provides that a special appropriation is an appropriation which states that it is necessary to meet an unforeseen disaster or other emergency, or to act without delay in the public interest. Each special appropriation shall be approved by not less than six Councilmembers. The Council may approve a special appropriation at any time after public notice by news release. Each special appropriation shall specify the source of funds to finance it.
2. A new coronavirus disease, named COVID-19, appeared in China in December 2019 and spread extremely quickly. On March 11, 2020, the World Health Organization declared the disease a pandemic. The April 11, 2020 situation report from the World Health Organization stated that the number of confirmed cases worldwide has exceeded 1.6 million, (approximately 1.5 million more than 1 month earlier). As of June 2, 2020, there were 11,731 cases and 584 deaths in Montgomery County.
3. To slow the spread of the disease, Governor Hogan declared a State of Emergency and has issued several Executive Orders with actions that include, but are not limited to, closing schools; prohibiting activities by non-essential businesses that restrict traditional on-site operations; closing senior centers and adult medical day care programs; limiting the number of people that can gather; and closing all gyms, movie theaters, and bars and restaurants (excluding carryout and delivery service).
4. The efforts to contain the spread of the disease and the disease itself continues to have a crippling impact on Montgomery County's local business community and non-profit organizations.
5. The Maryland Tech Council (MTC) has created the Business Continuity Task Force

(BCTF) to assist tech and life science entrepreneurs in Maryland that are navigating the economic downturn due to the health crisis. The BCTF includes experienced business leaders who have led businesses through the financial crisis, like the 2008 recession; this team will help small- and mid-sized tech and life science businesses plan for an optimal recovery and execute the recovery plan based on the economic conditions following the health crisis.

6. The MTC will partner with local jurisdictions and Economic Development Organizations (EDO) to market the BCTF’s services to small- and mid-sized tech and life science businesses.
7. The MTC is seeking financial support from Maryland jurisdictions and local Economic Development Organizations to provide the BCTF’s services to businesses in local jurisdictions at no cost to the businesses. The MTC is providing \$100,000 of undesignated funding to seed fund the BCTF’s early-stage operations.
8. A FY21 Operating Budget special appropriation is requested for the Office of the County Executive:

9. This special appropriation is needed so that MTC may provide its recovery services through the BCTF to small- and mid-sized businesses in Montgomery County at no cost to the County businesses.
10. The Planning, Housing, and Economic Development Committee amended the resolution during its worksession June 22, 2020, which included: 1) amending the resolution from a FY20 to a FY21 appropriation; 2) amending the source of funds from General Fund Reserves to Federal Grant Funds; and 3) amending the recipient of the funds from Maryland Tech Council to Office of the County Executive, Non-Competitive Award for Maryland Tech Council.
11. Notice of public hearing was given and a public hearing was held.

The County Council for Montgomery County, Maryland approves the following resolution:
