# **DESCRIPTION/ISSUE**

The County Executive has requested a special appropriation to the FY21 Operating Budget of the Department of Police in the amount of \$252,318, the Department of Corrections in the amount of \$106,950, and the Sheriff's Office in the amount of \$72,439 for the FY20 Bureau of Justice Assistance (BJA) Byrne Coronavirus Emergency Supplemental Funding. This appropriation will fund Personal Protective Equipment (PPE), active building/vehicle disinfectants, laptops for remote work, and warehouse equipment/logistical management software to enable the efficient storage of coronavirus related supplies.

This increase is needed because the public safety agencies were awarded funding from the Byrne Grant program to effectively respond to the coronavirus pandemic through the purchase of Personal Protective Equipment (PPE); active building/vehicle disinfectants; laptops for remote work, and warehouse equipment/logistical management software to enable the efficient storage of coronavirus related supplies, which are deemed important to the safety of the officers, professional staff, and citizens of Montgomery County. The source of funds is a federal grant. The special appropriation was introduced on July 14, 2020.

### **Background**

- 1. Section 308 of the Montgomery County Charter provides that a special appropriation: (a) may be made at any time after public notice by news release; (b) must state that the special appropriation is necessary to meet an unforeseen disaster or other emergency or to act without delay in the public interest; (c) must specify the revenues necessary to finance it; and (d) must be approved by no fewer than six members of the Council.
- 2. The County Executive has requested the following FY21 Operating Budget appropriation increases for the Department of Police, Department of Correction and Rehabilitation, and the Sheriff's Office:

- 3. This increase is needed because the public safety agencies were awarded funding from the Byrne Grant program to effectively respond to the coronavirus pandemic through the purchase of Personal Protective Equipment (PPE); active building/vehicle disinfectants; laptops for remote work, and warehouse equipment/logistical management software to enable the efficient storage of coronavirus related supplies, which are deemed important to the safety of the officers, professional staff, and citizens of Montgomery County.
- 4. The County Executive has requested a special appropriation to the FY21 Operating Budget in the amount of \$431,707 for the FY20 Bureau of Justice Assistance, (BJA) Byrne Coronavirus Emergency Supplemental Grant Funding, \$431,707 and specifies that the source of funds will be Federal Aid.
- 5. The public was notified by a news release.
