## **DESCRIPTION/ISSUE**

The County Executive recommends a special appropriation to the FY21 Operating Budget of the Montgomery County Fire and Rescue Service (MCFRS) in the amount of \$357,801 for the FY20 Assistance to Firefighters Grant Program – COVID-19 Supplemental. This appropriation will fund Personal Protective Equipment (PPE) and related supplies to prevent, prepare for, and respond to coronavirus. This increase is needed because funding was awarded from the Assistance to Firefighters Grant Program to effectively respond to the coronavirus pandemic through the purchase of Personal Protective Equipment (PPE), which is critical to the safety of fire and rescue personnel and the citizens of Montgomery County. The source of funds is federal aid.

Use of the Assistance for Firefighters - COVID-19 Grant Supplemental to support the purchase of personal protective equipment allows the County to preserve Coronavirus Aid, Relief, and Economic Security (CARES) funding for other purposes. The 15 percent in-kind match for AFG is less than the 25 percent match required for FEMA reimbursement. Grant funding is also assured, while FEMA funding is dependent on approval of reimbursement for expenses submitted. Introduction, Public Hearing, and Action are expected today.

## **SUMMARY OF KEY DISCUSSION POINTS**

- As a condition of this federal grant, MCFRS must contribute non-federal funds equal to or greater than 15% of the federal funds awarded, or \$53,670.18 for a total approved budget of \$11,471.36.
- The funding will be used to purchase PPE, including isolation gowns, eye protection, surgical face masks, and respirators.
- The use of this AFG to support the purchase of PPE allows the County to preserve Coronavirus Aid, Relief, and Economic Security (CARES) funding for other purposes. The 15% in-kind match for AFG is less than the 25% match required for FEMA reimbursement. AFG funding is also

assured, while FEMA funding is dependent on approval of reimbursement for expenses submitted.

- Council staff recommends approval to provide for the timely purchase of PPE.

1. **Article 1 Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

DHS financial assistance recipients must complete either the Office of Management and Budget (OMB) Standard Form 424B Assurances – Non-Construction Programs, or OMB Standard Form 424D Assurances – Construction Programs, as applicable. **Article 9 Civil Rights Act of 1968**

Recipients must comply with Title VIII of the Civil Rights Act of 1968, Pub. L. No. 90-284, as amended through Pub. L. 113-4, which prohibits recipients from discriminating in the sale, rental, financing, and advertising of dwellings, or in the provision of services in connection therewith, on the basis of race, color, national origin, religion, disability, familial status, and sex (see 42 U.S.C. § 3601 et seq.), as implemented by the U.S. Department of Housing and Urban Development at 24 C.F.R. Part 100. The prohibition on disability discrimination includes the requirement that new multifamily housing with four or more dwelling units—i.e., the public and common use areas and individual apartment units (all units in buildings with elevators and ground-floor units in buildings without elevators)—be designed and constructed with certain accessible features. (See 24 C.F.R. Part 100, Subpart D.)

**Article 10 Copyright**

Recipients must affix the applicable copyright notices of 17 U.S.C. §§ 401 or 402 and an acknowledgement of U.S. Government sponsorship (including the award number) to any work first produced under federal financial assistance awards.

**Article 11 Debarment and Suspension**

Recipients are subject to the non-procurement debarment and suspension regulations implementing Executive Orders (E.O.) 12549 and 12689, which are at 2 C.F.R. Part 180 as adopted by DHS at 2 C.F.R. Part 3000. These regulations restrict federal financial assistance awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs or activities.

**Article 12 Drug-Free Workplace Regulations**

Recipients must comply with drug-free workplace requirements in Subpart B (or Subpart C, if the recipient is an individual) of 2 C.F.R. Part 3001, which adopts the Government-wide implementation (2 C.F.R. Part 182) of Sec. 5152-5158 of the Drug-Free Workplace Act of 1988 (41 U.S.C. §§ 8101-8106).

**Article 13 Duplication of Benefits**

Any cost allocable to a particular federal financial assistance award provided for in 2 C.F.R. Part 200, Subpart E may not be charged to other federal financial assistance awards to overcome fund deficiencies; to avoid restrictions imposed by federal statutes, regulations, or federal financial assistance award terms and conditions; or for other reasons. However, these prohibitions would not preclude recipients from shifting costs that are allowable under two or more awards in accordance with existing federal statutes, regulations, or the federal financial assistance award terms and conditions.

**Article 14 Education Amendments of 1972 (Equal Opportunity in Education Act) – Title IX**

Recipients must comply with the requirements of Title IX of the Education Amendments of 1972, Pub. L. No. 92-318 (1972) (codified as amended at 20 U.S.C. § 1681 et seq.), which provide that no person in the United States will, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any educational program or activity receiving federal financial assistance. DHS implementing regulations are codified at 6 C.F.R. Part 17 and 44 C.F.R. Part 19.

**Article 15 Energy Policy and Conservation Act**
